



The European SRI Transparency Code Manual Logo Specification

The proper name for the Code is European SRI Transparency Code

As of May 2008, signatories of the European SRI Transparency Code can no longer use Eurosif logo on their funds document. Instead, Eurosif has developed a logo to be used specifically and only by signatories of the European SRI Transparency Code.

Logo

The use of the official Logo is a primary part of the Transparency Code identity. The Logo must be incorporated on the fund's response to the Code without exception and if possible on the media chosen to communicate the information required by the Code (e.g. web-based and/or printed material). The Logo must be consistently applied at all times in a manner defined by this code.

The logo is made of two gold rings with the letters in "Transparent" overlapping. The letters in "Transparent" appear in a way which aligns the 'tra' in transparent within the smaller circle, and the "ns" within the larger circle. Ridges and six stars appear on the edge of the large circle.

Where to Place the Logo

The Transparency Code Logo can only be used in documents or next to information pertaining to Socially Responsible Investment (SRI).

The Transparency Code Logo can be used on the front cover of a document only if the document relates purely to SRI. If the document covers a range of SRI and mainstream products, the SRI symbol can only be used on the pages that relate directly to SRI products.

Disclaimer Accompanying the Logo

When using the Logo on fund's materials, the logo must always be accompanied by a disclaimer which describes what it represents, so there can be no confusion about what it means.

If the Logo is used on the front cover of a formal document, you do not have to include the disclaimer on the front cover. However you must repeat the Logo either in the document's disclaimer section or a location reasonably close to the front cover and include the disclaimer statement next to it so that consumers understand what the Logo means.

Logo Usage Rules

- The Eurosif logo contains six colors; three colors for the text and three colors for the rings. When in color, the precise colors must be used. When monochromatic the six values still must be observed.



Logo Usage Violations

- Never attempt to recreate the logo
- Never replace any of the typeface
- Never replace the colors of the logo
- Never remove or alter the circle
- Do not skew or distort the logo in any way.
- Do not place the logo on a textured background or colored background that will impede its readability.
- Do not use a negative image of the logo.
- Do not use scans or low quality copies of the logo. Use an official file or hard copy of the logo.
- Do not create pattern with the logo.
- Do not let the logo be distorted by improper scaling.

Improper Proportions	Improper Proportions
A logo where the outer circle is significantly larger than the inner circle, making the "trans" text appear very small.	A logo where the outer circle is significantly smaller than the inner circle, making the "trans" text appear very large.
Improper Colors	Improper Resize
A logo where the "trans" text is blue and the "parent" text is cyan, deviating from the standard yellow and white color scheme.	A logo where the entire emblem is scaled up to a much larger size, appearing blurry and pixelated.
Improper Colors	Improper Size
A logo where the entire emblem is scaled down to a very small size, appearing blurry and pixelated.	A logo where the "parent" text is disproportionately large compared to the "trans" text, and the entire emblem is scaled down.
